

VASION MINOR PARTICIPANT WAIVER AND RELEASE FORM

1. INTRODUCTION AND PURPOSE

This Waiver and Release Form ("Form") is required for all participants under 18 years old ("Minor Participant") attending the Southern Utah Code Camp ("Event") at Vasion, Inc. 432 S Tech Ridge Drive, St. George, Utah 84770 ("Vasion").

PLEASE READ THIS DOCUMENT CAREFULLY BEFORE SIGNING. This document contains important information about the Event and includes a release of liability and waiver of certain legal rights. By signing this Agreement, you agree to and understand the terms set forth below.

3. VASION'S ROLE

Vasion is not the host, sponsor, or promoter of the Event. Vasion is solely donating the use of its building for the Event and has no obligations in planning, organizing, supervising, or conducting the Event.

4. RISKS

Participation in the Event may involve inherent risks, including but not limited to:

- 1. Physical injuries related to indoor and outdoor activities;
- 2. Potential property damage or loss;
- 3. Allergic reactions;
- 4. Risks associated with overnight stays in a non-residential building;
- 5. Emotional or social challenges;
- 6. Technology-related risks;
- 7. Other unforeseen risks associated with commercial buildings.

5. LIABILITY RELEASE AND INDEMNIFICATION

By signing below, the undersigned parent/legal guardian and Minor Participant acknowledge and agree:

- Parent/Guardian has been fully informed of and understands the risks associated with Participant's involvement in the Event, including but not limited to the risks mentioned above.
- To the fullest extent permitted by Utah law, you hereby release, waive, and discharge Vasion, its officers, directors, employees, and agents from any and all claims, liabilities, damages, or causes of action arising out of or related to the Minor Participant's attendance or participation in the Event, including but not limited to claims for personal injury, illness, property damage, or death, whether arising from ordinary negligence or otherwise, except for claims resulting from Vasion's gross negligence or willful misconduct, which cannot be waived under Utah law.

- You understand that Vasion's liability as a premises owner is limited to maintaining the premises in a reasonably safe
 condition and warning of known hazards. Vasion is not responsible for supervision, security, or the conduct of any
 Event activities or participants.
- You agree to indemnify and hold harmless Vasion from any claims, damages, or expenses (including attorneys' fees)
 arising out of the Minor Participant's actions or omissions while on Vasion's premises, except to the extent caused by
 Vasion's gross negligence or willful misconduct.
- You acknowledge that, under Utah law, waivers signed by parents/guardians on behalf of minors are generally
 disfavored but may be enforced for ordinary negligence if clear, unambiguous, and not against public policy. This
 waiver does not release Vasion from liability for gross negligence or willful misconduct.

6. MEDICAL AUTHORIZATION AND EMERGENCY CONTACT

In the event of a medical emergency, you authorize Event staff and/or Vasion personnel to seek and provide emergency medical care for the Minor Participant and to release medical information to healthcare providers as necessary. Parent/Guardian agrees to be financially responsible for all expenses incurred for such medical treatment.

No royalty, fee, or other compensation shall become payable by reason of such use. You waive any right to inspect or approve the finished product or any use of such images or recordings.

8. PROPERTY DAMAGE

This Form shall be governed by and construed in accordance with the laws of the State of Utah. Any dispute arising under this Form shall be brought exclusively in the courts of Utah.

10. SEVERABILITY

If any provision of this Form is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.
